Please include with this application a paragraph written in third person about the items you plan to sell. These descriptions will be used on the Fiber Christmas website and other advertisements. Those accepted will receive an invoice within two weeks of the deadline on January 1, 2024 or have their attached check deposited. If for some reason, a vendor cancels their booth, the next candidate in line will be contacted.

Booth set-up will be Friday morning from 8 am - 12 pm. Backdrops and table coverings are not provided. Vendors and/or vendor associates are required to be set-up and present during the entire festival from Friday 12 - 6 pm and Saturday 8 am – 6 pm. If an emergency arises during the festival that you must leave for, please inform the staff immediately. Any vendor who fails to observe these rules will automatically be restricted from attending as a vendor in the future. If you have questions concerning any area, contact Kate Lowder.
